#### RECOMMENDATION

Adopt Resolution No. 20-\_\_\_\_\_, Approving Disability Retirement of Martin Justinich.

#### **RESULT OF RECOMMENDED ACTION**

Applicant Martin Justinich will receive a Disability Retirement (ATU).

#### FISCAL IMPACT

Retirement benefits are funded under the Retirement Plan for Regional Transit Employees who are Members of **ATU** Local 256, hereinafter the "Retirement Plan."

#### **DISCUSSION**

**Eligibility:** Martin Justinich, hereinafter the "Applicant," is a member of the Retirement Plan, pursuant to Article 3 of the Retirement Plan.

**Vesting:** The Applicant was in the continuous employ of the District since October 16, 2003 as a full-time employee. He has completed at least 10 Years of Service and achieved 100% vesting pursuant to Article 5 of the Retirement Plan.

**Service:** The Applicant was an Eligible Employee within the meaning of Article 2 of the Retirement Plan when the illness or injury at issue occurred, and terminated service as an Employee of the District on July 31, 2020.

**Disability:** The Applicant submitted a Disability Retirement Application on August 1, 2020. Although the Applicant has not been examined by the Board's physician, there are special circumstances in this case that the Board may determine warrant a departure from the usual procedures and approval of the Disability Retirement Application based on the medical facts reported by Staff.

Eligibility for a Disability Retirement requires that the Applicant have a "Disability," which is defined in the Plan as "a permanent physical or mental condition of an Eligible Employee, resulting from illness or injury, that disqualifies the Employee from performing the duties of his or her position with the District for reasons not constituting cause for discharge." The Plan provides that the Board has sole authority to determine whether a

Disability has occurred, and that the Board will make its determination based on medical evidence.

Under the Board's "Procedures to Process Application for Disability Retirement" ("Procedures"), disability retirement applicants are to be examined by the Board's physician, who also reviews the applicant's medical records and issues a written report to the Board that includes the physician's opinion regarding whether the applicant has a "Disability" as defined in the Plan.

Currently, the Board's physician provides these services pursuant to the District's contract with Sutter Medical Foundation. However, Staff was recently notified that the Board's physician has ceased providing physical examinations for disability determinations, and that Sutter cannot make another physician available to provide those services. Given the extraordinary facts in this case, Staff conferred with Legal Counsel, who has advised that the Board may elect to waive its Procedures, and exercise its authority to make the required determination of Disability with respect to the Applicant without a written report from an examining physician, based on the known medical evidence as reported by Staff.

Staff has reviewed the record assembled in support of this Disability Retirement Application and confirmed the following information:

- 1. Applicant was diagnosed with Diabetes Mellitus approximately 20 years ago.
- 2. Applicant subsequently experienced neuropathy, foot problems and, ultimately, bilateral below-the-knee-amputation (BKA).
- 3. Applicant is currently on dialysis and suffering from Stage 5 chronic kidney disease (CKD).
- 4. Applicant requested accommodation and participated in interactive meetings prior to submitting his Disability Retirement Application, but was informed that the District could not offer permanent, modified duty or alternate employment.

Consistent with these medical facts, Staff is submitting this Disability Retirement Application for action without the benefit of a separate report from the Board's physician.

Absent a Disability Retirement, Applicant will not be eligible to receive a lifetime benefit from the Retirement Plan until December 2026.

**Retirement Date:** The Applicant's benefits will commence on August 1, 2020, provided the Retirement Board determines that the Applicant has a Disability as defined in the Plan and approves the Disability Retirement.

**Allowance:** With approval from the Retirement Board, Staff will direct the actuary for the Retirement Plan to calculate the retirement benefits to which the Applicant is entitled.
